KILA collaborates with the Sri Lanka Institute of Local Governance (SILG) and All India Institute of Local Self Governments (AIILSG), Mumbai to conduct international course in decentralised governance and poverty alleviation. KILA will be elevated to the status of University in the near future. It is a pleasant news for the fraternity on decentralisation that the year of 2015 was Silver Jubilee for KILA.

In the context of election in the Local Governments of Kerala in November 2015, KILA has already conducted capacity building programmes. Genesis

Kerala Institute of Local Administration (KILA) is an autonomous institution functioning under the Ministry of Local Self Government, Government of Kerala. It was registered under the Travancore-Cochin Literary, Scientific and Charitable Societies Act 1955. Ever since its inception in 1990, KILA has been engaged in myriad of capacity building interventions on local governance and decentralization; including training, action-research, publications, seminars and workshops, consultancy, documentation, handholding and information services.

Objectives

KILA has the mandate of facilitating and accelerating the socio-economic development of the State through strengthening the

Local Self Government Institutions (LSGIs). As a Government of Kerala supported nodal agency for training, research and consultancy, KILA is committed to the following objectives:

- Undertake various training programmes for the Elected Representatives and Officials of Rural and Urban Local Governments of Kerala,
- Facilitate and strengthen decentralized planning process,
- Undertake action-oriented research activities,
- Document best practices on local governance for dissemination,
- Organize seminars, workshops and discussions, and
- Formulate policy documents.

Collaboration with other Agencies

Other than plan fund of Governments of Kerala, KILA avails the funding support from MoPR, MoUD, MoHPA and MoRD through various schemes of Central Government and international agencies as well.

Ministry of Panchayat Raj (MoPR), Government of India

KILA undertakes capacity building programmes through various schemes of MoPR, Government of India.

Rajiv Gandhi Panchayat Sashakthikaran Abhiyan (RGPSA), restructured as Rashtriya Gram Swaraj Abhiyan (RGSA), is a centrally sponsored scheme launched to strengthen the Panchayati Raj system of the country and to address the critical gaps. This scheme is applicable to all States/ UTs including those, which presently are not covered by Part IX of the Constitution. State of Kerala has been supported under RGPSA scheme, matching the funds of State Plan.

KILA, functioning as the State level Panchayati Raj Resource Centre of Kerala, is the implementing agency of Capacity Building and Training (CB&T) of Elected Representatives and Functionaries, which is





a major component under the Scheme. KILA is the designated nodal agency of the Government of Kerala for carrying out training, research, and consultancy in the area of decentralization and local governance. It is the exclusive institute of the Govt. of Kerala for the capacity building of Local Government functionaries - both elected and officials, of rural and urban.

KILA also collaborates with several international/national level organizations like UNDP, World Bank, UNICEF, Swiss Agency for Development and Co-operation (SDC), Sri Lanka Institute of Local Governance (SILG), etc.

KLGSDP (Kerala Local Government Service Delivery Project), Government of Kerala

In order to address issues related to the institutionalization phase of decentralised governance, Kerala State has entered into agreement with Kerala Local Government Service Delivery Project (KLGSDP) funded by the World Bank. KLGSDP is providing financial assistance to address the issues on institutions and to raise the level of service delivery by Local Governments. KLGSDP work with the basic objective of strengthening local government finances and service delivery. Under KLGSDP, KILA is shouldered with the responsibility of developing Manuals and also system building.

UNICEF - CRC

A Child Resource Centre (CRC) has been set up in KILA with the support of UNICEF. The





aim of CRC is to ensure child right governance through Local Government Institutions. The CRC has been functional since August 2011. The CRC functions with the following core objectives:

- (i) Provide resource support for effective Child - centric governance,
- (ii) Referral point for all governance issues around children,
- (iii) Facilitate Local Governments for effective child centric planning, and
- (iv) Facilitate policy intervention, keeping in view of second generation issues of children.

Setting up child friendly local governance based on the four set of child rights setting up child friendly local governance based on the four set of child rights envisaged in



UNCRC viz: Survival, Development, Protection and Participation, is the overall focus of RC.

HUDCO

The Institute has collaboration with HUDCO/ HSML. Centre for Urban Governance (CUG), established at KILA, is intended to support the capacity building activities for the urban local bodies in Kerala. The CUG conducts training, research, documentation, and consultancy for housing and urban development in Kerala.

Research Centre Affiliated to Central University of Kerala (CUK)



KILA has collaboration with Central University of Kerala, which was established in 2009. KILA has gained the status of Research Centre of the Department of International Relations and Politics, under the School of Global Studies in CUK. The five faculty members of KILA (including Director) has been provided guideship by CUK and allotted 20 PhD seats in KILA.

Internship Programme

To know about the academic functioning of KILA, and to study the decentralisation and



local governance, various academic institutions make use of KILA for internship. Interns would be trained under the guidance of Faculty members of KILA. This programme gives an opportunity for the Interns to learn about the local governance, where by it is also helpful for the activities of KILA, especially to undertake mini-research on Local Governance.

Human Resource Support

The personnel strength of KILA is around 50, spearheaded by the Director. The personnel are spread through broad inter-connected divisions of academic and administrative segments. The operational aspects are subject to peer review through constant monitoring. The staff and officer's meetings will be held frequently to discuss operational issues of the capacity building programmes



of KILA. The academic activities are planned and monitored by the Academic Committee.

Faculty Team

The present numeric strength of core faculty team in KILA is marginal at three. However, this institutional constraint is overcome by engaging Training Associates and consultants. KILA has been able to manage the massive training programmes by availing the services of Consultants and a pool of potential resource persons comprising of policy makers, academicians, administrators, researchers, and practitioners in the field of decentralised governance and development. They numbered around 850.

Location

KILA is situated at Mulamkunnthukavu, 11 km north of Thrissur city on the Thrissur-Shornur Road in a picturesque 25 acre campus. The serene and salubrious atmosphere of the campus amidst the scenic landscape of the surrounding hills provides a congenial atmosphere for learning. The nearest international airport, Cochin (Nedumbassery) is 65 kms from KILA. The participants arriving by train can alight at Thrissur railway station. Direct taxi/auto rickshaw and bus services are available to reach KILA campus.





Infrastructural Facilities

KILA has excellent training infrastructural facilities.

- the training block is a three storied building,
- six spacious lecture halls,
- three air-conditioned conference halls,
- one auditorium, and
- one computer lab.

This enables KILA to run several training programmes at a time. These halls are named as below:

- There are two guest houses, namely i) Sahyadri Guest House, ii) Aravalli Guest House in the campus of KILA for providing boarding and lodging facilities to the



participants. These guest houses have well-furnished rooms for double/single occupancy with attached toilet and bath to accommodate about 200 participants at a time. The multi-purpose auditorium can accommodate 600 persons. The Computer Lab has strength of 50 systems. The participants of national and international programmes are provided with air-conditioned accommodation.

In addition to guest houses, South Asia School (SAS) is set up in KILA. Conference hall, library, canteen, and guest house are available in SAS at international standards. SAS has 26 suits to accommodate 52 participants.

KILA has three vehicles for day-to-day use. More vehicles are hired on daily basis for the purpose of training and exposure visits.

- KILA is equipped with modern training equipment's, viz. LCD Projector, Film projector, LED TV, Video Conferencing Equipment's, Display Boards. Now KILA has WiFi connectivity within the campus. KILA has a Computer Centre, which is networked with the computers of the Faculty and Administration. Modern communication media, including internet, fax, computers are installed in the



institute to facilitate easy access to any part of the country/world.

- KILA has now launched office automation software 'COKILA' with the support of NIC.
- The collection of books and periodicals of the Library is focused on the themes of Panchayati Raj, local governance, participatory planning, poverty alleviation, rural development, urban development and management. The library has a collection of over 10,000



books and over 200 journals, focused on KILA's thrust areas. Efforts are on to develop the library into a full-fledged information centre on local governance, with state of the art facilities like computer and internet. With this purpose, a new library complex has been constructed. Library is now computerised, using open source software 'KOHA'.



- Recreation facilities have been developed in the campus for indoor as well as outdoor games. There is a multi-purpose auditorium, where participants can play shuttle badminton, table tennis, chess, etc., and watch TV. The hall is also utilized for cultural programmes.
- The attractiveness of KILA, situated in idyllic settings, is enhanced manifold by the beautiful sprawling lawns, and a galaxy of ornamental and flowering plants. Visitors will be captivated by the serene and delightful ambience in the campus. The Buddha Park, Green Park, Eden Gardens, Shalimar Baag, Vrindavan Garden, Star Garden, Herbal Garden, Traditional Grama Sabha, Thinkers Retreat Hut, Terrocota Garden, Tharakoottam (Open Air Auditorium) Water fountain etc. have a soul-lifting effect on the inmates. The atmosphere is





ideal for morning and evening walk and jogging. Focusing on Gandhi Grama Swaraj, the Art Gallery set up in KILA recently attracts people from far and wide. It is first of its kind in India, spreading Gandhiji's messages on Grama Swaraj through splendid paintings.

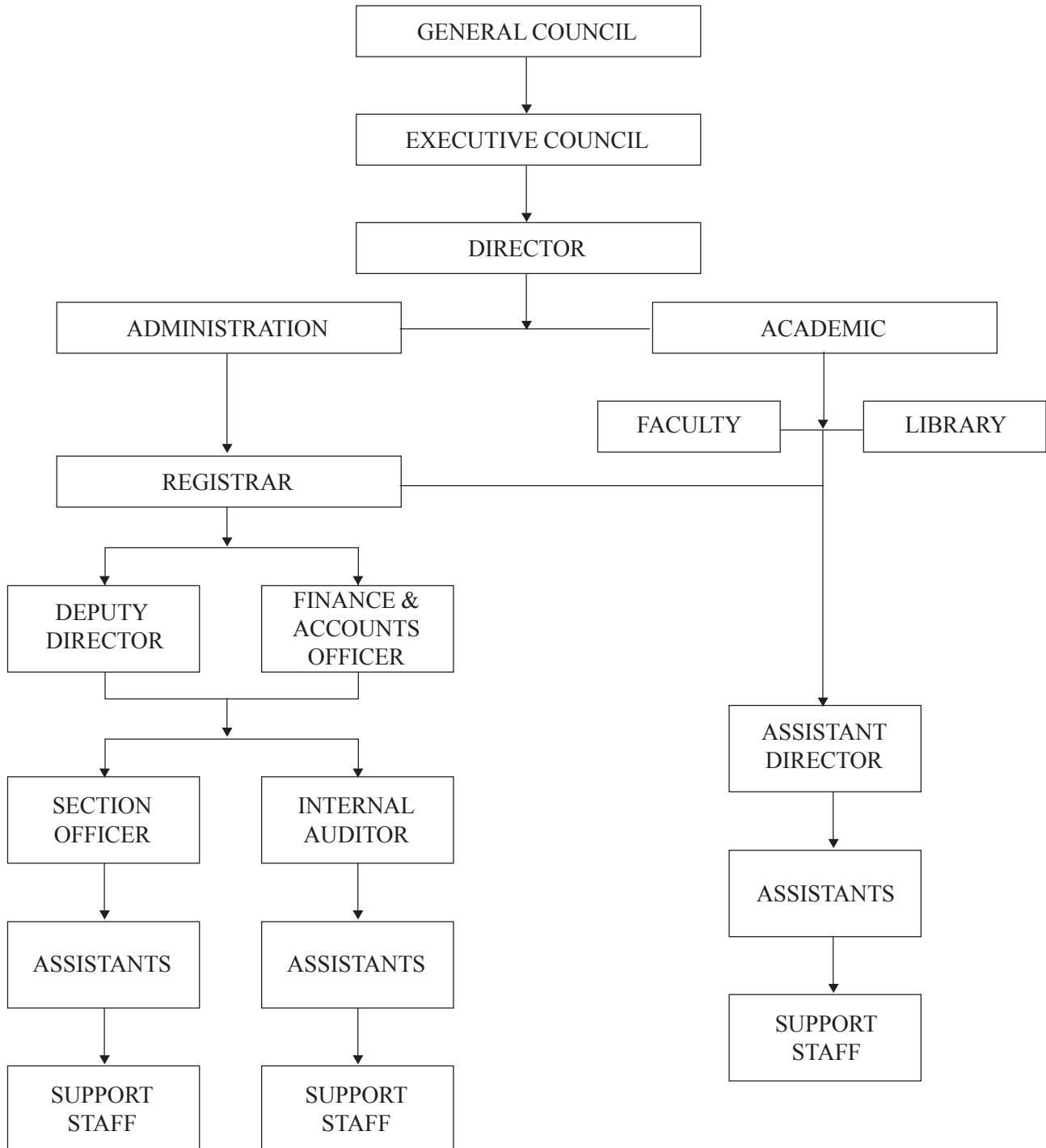

Training Programme for 2016-17

In the light of election to the Local Self Government Institutions (LSGIs) in November 2015, KILA had envisaged the induction training in three phases. The first two phases of training to the newly elected representatives [first phase, one day training on public administration; second phase, two day training on local government plan formulation] have already been conducted. The third phase of training is for Standing Committees. Of this, Finance Standing Committee training has already been commenced. In the year 2016-17, attention would be given for providing training to the remaining Standing Committees. The ongoing trainings such as TQM, Office Management, Public Administration, Management Development Programme, Soft Skills, Grama Sabha, Accounting, etc. will also be continued.

**LPD A6: Concurrent Decentralised Training System (CDTS)

A new system of concurrent training, massively covering the entire staff of GPs on contemporary issues has been initiated by KILA; with the facilitative support of Help Desk. The CDTS makes use of existing institutional mechanism as below. Deputy Directors of Panchayats (DDPs) of all the districts [14 Nos.] conduct a monthly meeting for the Secretaries of GPs [978 GPs] in the first week every month. In concurrence with the Director of Panchayat, KILA avails a training slot of short session in the monthly review meeting. Accordingly, KILA conducts training on contemporary issue for 60 to 90 minutes duration. The extension faculty members of KILA are equipped through ToT to conduct these trainings in 14 districts at a time. The FAQs would also be dealt within the session. On completion of 14 events, 978 Secretaries are imparted training on the contemporary topic. The 978 Secretaries who got training on the monthly meeting will share the knowledge on the very next working day in their GPs concerned. So, the entire staff of 978 GPs (around 12000) will be covered through 978 events in one day.



*LGM A2: Diploma in Local Governance (DLG)

Background

The Grama Panchayat Officials, especially Secretary, Assistant Secretary, and Junior Superintendent, are expected to perform multi-faceted functions on local governance and development. The efficient functioning of Grama Panchayat Officials requires thorough knowledge on Kerala Panchayat Raj Act and allied Rules, proficiency in applying management tools to solve organisational problems. Also requires soft skills for effective communication, positive interpersonal relations, creativity, etc. These skills and knowledge of officials help to create positive work environment and cordial relation with stake holders of Grama Panchayat. In view of strengthening these knowledge and skills, KILA envisage a Diploma Programme that targets to enhance the capacity of young Officials of Grama Panchayats on three core areas viz. (i) Kerala Panchayat Raj Act (KPRRA) and Rules, (ii) Management Proficiency, and (iii) Soft Skills. This programme is featured with a slogan '3-in-1' as the participants will able to gain knowledge and skills on three core areas through one diploma course.

Achievements through this Programme

The participants will have through knowledge, skills, and capacity to perform efficiently and effectively and be able to:

- Apply professionalism in office management, record management, personnel management, finance management, time management, and project management,
- Perform the tasks by complying the Acts and Rules,
- Manage and positively interact with multiple stakeholder groups,
- Deliver the services efficiently and effectively,
- Timely reporting to various stakeholders, and
- Generate innovative ideas and projects.

Course Methodology

The DLG shall follow Blended Learning Methodology (BLM); a formal training programme in which the participants learn through online (distant mode), combined with classroom methods (direct contact mode).

Participants

Secretaries, Assistant Secretaries or Junior Superintendents of Grama Panchayats with an education of minimum Graduation of any discipline and computer literacy shall be selected for the programme.
